Konoike Transport to accelerate the growth of its priority business in India

# **Group Company in India Converted into a Management Company**

Konoike Asia (India) will be renamed and begin operations as Konoike India

Konoike Transport Co., Ltd. (Head Office: Chuo-ku, Osaka; Representative Director, Chairman, President and Chief Executive Officer: Tadahiko Konoike; hereinafter referred to as "Konoike Transport") will rename Konoike Asia (India) Pvt. Ltd., its group company in India, to Konoike India Pvt. Ltd. (Head Office: Gurugram, India; Managing Director: Kazuhiro Hasumi; hereinafter referred to as "KIPL") in order to accelerate business expansion in line with its growing business in India. KIPL will begin operations on October 1, 2024 (Tues.) as the company overseeing the Konoike Group's local subsidiaries in India.

The Indian market is expected to see a large increase in demand and high growth, so Konoike Transport has been expanding and enhancing its operations in that market. Since establishing a base in India in 2008, Konoike Transport has developed its forwarding, engineering, rail transport, and medical businesses<sup>\*1</sup> and is planning to enter the steel business as well<sup>\*2</sup>.

A management company, KIPL will enhance governance and compliance and improve operational and management efficiency through centralized management while spearheading the Group's business expansion in India. Konoike Transport has designated its India business as a priority business in its Medium-term Management Plan (fiscal year ended March 31, 2023-fiscal year ending March 31, 2025)\*3 and aims to further expand its business in India so that the country can serve as a second base.

I am concerned that Japan's global standing will further decline if we do not compete on the global forefront in India. India should be a second base for Konoike Transport. We want to build a business infrastructure in India to augment the Konoike Group's headquarters in Japan. We want to break out of the mold of being a Japanese company and lay down roots in the Indian market, advancing and growing with the market as an Indian (global) company.


